The theme of this year's annual report is **HOPES Rising**. The idea came as a reflection during our preparations for the Ribbon Cutting Ceremony for the Annex in Hoboken. The building in the former courtyard of the David E. Rue Building came out of sheer necessity after the losses HOPES sustained as a result of floods brought by Hurricane Sandy. The children and staff displaced by the damages to our offices and classrooms were thankfully relocated so that services could continue, but the official opening of the Annex felt like a true homecoming for me and the other members of our team who lost their work "home" in the storm.

In our 2013 Annual Report, which featured the aftermath of Hurricane Sandy, we reflected back on how far we had come then, and it especially feels appropriate now. We are including testimonials from individuals featured in our 2013 Annual Report to truly have a sense of the impact HOPES and its services have on people's lives.

This past year, we served over 1,000 children ages 0-5, and over 3,000 youth, adults, and seniors. We are proud to have formalized our vision of building a future where communities thrive and are empowered to build self-sufficiency, and our values of Honesty, Opportunity, Partnership, Empowerment, and Success. As always, included in our report are our most impactful results, which would not be possible without the work and dedication of our staff and the support of our Board of Directors.

In closing, I want to thank and acknowledge our former President/CEO, Ora Welch, who retired after 24 years of committed service. I look forward to continuing our work of providing community services to fight the causes of poverty.

Over five years ago, when Nyesha enrolled her daughter Abigail in HOPES Early Childhood Program, she, herself, was taking college classes and seeking an internship and parttime job to provide for her daughter. In HOPES 2013 Annual Report, Nyesha remarked:

"HOPES offered classes about coping with parenthood and a great program for my daughter to attend while I further my education... so I can provide for my daughter as best I can. I thank HOPES Head Start so much!"


Now today, Abigail is attending Kindergarten in Middlesex, NJ and Nyesha is proud to be graduating from St. Peters College with a Marketing Degree and a minor in English. She also has a permanent job in which she is able to provide for her daughter. Nyesha reflects on the impact that HOPES Early Childhood Program made in her and her daughter's lives:

"When I think back about five and a half years, I was a single teen mother struggling and trying to go to school. I was receiving social services and wondering how was I going to make it. I enrolled my daughter Abigail into HOPES Early Head Start program (0-3 years old) and my life began to change. I was able to get a part time job and start school while my daughter received excellent care at school. As time went on she transitioned into HOPES Head Start program (3-5 years old). While in HOPES Head Start, I was able to work full time because of the before and aftercare services that was offered.

Today, Abigail is excelling in Math and perfecting her Spanish thanks to HOPES Head Start. She is a great story teller, loves to read, and spell.

I owe this to HOPES for providing before and aftercare services, great staff, and a safe learning environment. If I had to use two words to describe my total experience with HOPES, I would say THANKFUL and APPRECIATIVE. I don't know what I would have done without both programs."

OUT OF ADVERSITY, A NEW BEGINNING

On September 6, 2017, HOPES CAP, Inc. held the Ribbon Cutting Ceremony and unveiling of the new HOPES Annex, almost 5 years after the devastation of Hurricane Sandy. The opening of the new Annex marked a major milestone in the Hoboken community's recovery from the devastation of Hurricane Sandy in 2012. HOPES was heavily impacted by the storm, as agency offices at the Multi-Services Building at 124 Grand Street and early childhood classrooms at other locations in Hoboken were lost to severe flood damage.

Many key political and community figures essential to the progress and mission of the HOPES community were present at the event alongside many HOPES staff members, parents, and community members at large. The ceremony included a surprise building dedication to Frank Raia, the Chair of the HOPES Board of Directors, who has been a committed member of the HOPES community and has served on the HOPES board in various capacities for 35 years.

In the aftermath of Hurricane Sandy, HOPES CAP, Inc. remained on the front-lines of the community and continued helping those in need through its various programs. The Department of Health and Human Services, the Administration for Children and Families, and the Office of Head Start at both the National and Regional levels provided the monetary assistance necessary for the construction of this new facility. With this aid, we were able to recreate engaging classrooms, construct efficient and technologically modern administrative offices, as well as provide spaces for the various community services programs we offer that are so essential to our communities. The building, in what used to be the courtyard of the David E. Rue School at 301 Garden St., houses several administrative offices, three classrooms, and a state of the art rooftop playground.

As part of the ribbon cutting ceremony, HOPES also dedicated the Infant and Toddler wing in the David E. Rue building in honor of Michele Russo. Michele was a dedicated and committed board member whose work centered around providing access to quality free educational programs for infants and toddlers to the Hoboken community.






Clients Served


Number of clients served in the past year.



"I came to HOPES from the CWEP program through Hudson County Welfare. The staff at HOPES was great and very welcoming. I had no idea that volunteering my time would lead to a full time job. As it turned out, HOPES offered me a full time position as Community Services Advocate. HOPES has me on the road to achieving my goals."

Now today, Jessica has advanced to a position in Human Resources. Her experience of providing quality customer service to clients at the Family Resource Center is now empowering the staff who come to her with Human Resources questions. Jessica reflects on her time at HOPES:

"I was enrolled in the HOPES Head Start program as a child. Twenty-six years later I found myself back here as volunteer through the Community Work Experience Program (CWEP) in the Community Programs Department. In Early February of 2013 I received a call from Evelyn Mercado asking if I were interested in interviewing for a Community Services Advocate position, by then I had been volunteering for over a year. I was a Community Services Advocate for four years.

Growth and advancement are encouraged here at HOPES, when the opportunity arose to apply internally for an advanced position I took it. Today I am the Human Resources Administrator at HOPES CAP, Inc. I, along with many others, am proof of the great opportunity that exists here at HOPES CAP, Inc. Our core values are evident through my experience here. Honesty, Opportunity, Partnership, Empowerment, and Success. I look forward to the future and experiencing new growth and success here at HOPES!"
